

## DONATION CONDITIONS

### STATEMENT

By accepting this data management statement, the User agrees that Közérdekes (Jókai Mór utca 1.,Perkáta, 2431 Hungary) stores it in its own user database and transfers it to

- PayPal (Europe) S.à r.l. et Cie, S.C.A.

as the data manager, the following personal data that the User provides about himself/herself: last name, first name, postal code, town, address, telephone number, e-mail address.

The purpose of data processing and data transfer is: providing customer service assistance to Users, newsletter subscription, confirmation of transactions (payment of donations by bank card or transfer) and fraud monitoring (a fraud detection system supporting the control of bank transactions initiated electronically) for the protection of Users.

Neither Közérdekes, nor [PayPal \(Europe\)](#) will pass on the data to third parties. You can access the general terms and conditions of the given bank or payment platform by clicking on its name.

The User consents to the storage and use of the contact details provided by him/her for the purpose of contacting the Public Interest Supporters. The User may at any time request the deletion or correction of his/her data, prohibit its further use, or request information about the details of the processing of his/her data by emailing [kozerdekes@kozerdekes.org](mailto:kozerdekes@kozerdekes.org).

Közérdekes processes your personal data only in accordance with this privacy statement and applicable data protection laws. However, if you still wish to make a complaint about the processing of your personal data or are otherwise dissatisfied with the way we handle your data, you have the right to lodge a complaint with the supervisory authority.

## **WHAT TO LOOK OUT FOR?**

- Keep a record of your donation details!
- Keep a record of your payment transaction data! (transaction ID, authorization number)
- Ensure that unauthorized persons cannot access your card information!
- Use a browser that supports the option required for SSL encryption!

## **SECURITY**

SSL is an abbreviation for Secure Sockets Layer encryption. Every bank/payment interface involved in the electronic support of the Közérdekes organization has an encryption key that protects the communication channel. This encryption method is used in a significant percentage of the world's electronic commerce. The browser used by the customer uses SSL to encrypt the cardholder's data before sending it, so it reaches the bank in coded form. The bank only handles the card details necessary for the payment transaction on the SSL-encrypted payment page. Only the bank has access to the data provided on the payment page; the bank will not forward it to Közérdekes. The site will inform you about the transaction result after payment. To pay by card, your internet browser must support SSL encryption.

## **ACCEPTED CARDS**

PayPal's online payment system allows the use of Mastercard/Maestro, VISA and VISA Electron (Electron only if permitted by the issuing bank) and American Express bank cards, as well as payments with web cards suitable for online use.

## **INFORMATION FOR ONE-TIME DONATION**

Payment (hereinafter: "Payment") is a function of the Buyer's (Donor's) PayPal account or of the bank card acceptance provided by PayPal, which means that the Buyer (Donor) initiates a payment with the bank card details provided during the transaction.

By accepting the donation terms and conditions and clicking the "Donate" button, you will be redirected to PayPal's secure payment page, where you must log in to your PayPal account to start the payment or, if you choose to donate by card, you must fill in your card details and follow the instructions given by the additional payment page. You can read the payment service provider's information on data processing here: [PayPal \(Europe\)](#).

In the event of payment, after a successful transaction, the bank will initiate the debiting of the Cardholder's account with the donation amount. The donated amount will be deducted / blocked from your card account/PayPal account/account associated with your PayPal account.

If you do not receive confirmation of the transaction's success, the transaction is unsuccessful.

If you would like more information about the result of the transaction, or in the event of its failure, the reason for it, or the details, please contact your account-keeping bank.

### **INFORMATION FOR RECURRING DONATION**

Recurring payment (hereinafter: "Recurring Payment") is a function provided by PayPal, which is a function related to the acceptance of bank cards provided by PayPal through the Buyer's (Donor's) PayPal account, which means that the account or bank card details provided by the Buyer (Donor) during the transaction can be used to initiate new payments in the future without having to re-enter the account or bank card details.

After setting up Recurring Payment, the bank's system will debit the selected account, bill or bank card of the Donor (in the bank's terminology: Buyer) once a month/year with the selected amount, according to the selected value. If the debit fails, the debit is retried the next day. The cancellation of the recurring payment can be announced at the contacts of the Public Interest (Jókai Mór utca 1., Perkáta, 2431 Hungary) (e-mail: [assistance@kozerdekes.org](mailto:assistance@kozerdekes.org); telephone: +36/30 19 66 505).

By accepting this statement for the use of recurring payments, you consent to the fact that subsequent payments after a successful registration transaction will be initiated by Közérdekes without the need to re-enter the selected payment account details/bank card details and without your consent per transaction.

The Service Provider (in this case, the service provider: Közérdekes) is directly liable for recurring payment transactions initiated incorrectly or illegally by the Service Provider, and any claims against the Service Provider's payment service provider are excluded.

Bank card details are handled in accordance with the card company's rules. Neither Közérdekes nor PayPal (Europe) has access to the bank card details.
